The new Guidelines replace the 'Guidelines for transport and preparation for shipment of live wild animals and plants' adopted by the Conference of the Parties at its second meeting (San José, 1979) In Resolution Conf. 10.21 (Rev. CoP16) , on Transport of live specimens , the Conference of the Parties recommends inter alia that:

The transport of live animals must be well planned, well prepared and effectively executed! For long distances, air transport should be the first consideration! Animals must:

CITES GUIDELINES FOR THE NON-AIR TRANSPORT OF LIVE WILD ...

Transport of live specimens Articles III, IV, V and VII of the Convention require that the Management Authorities of the state of export be satisfied, before granting any permits, that live specimens will be so prepared and shipped as to minimize the risk of injury, damage to health or cruel treatment.

To obtain optimum success in propagation and cultivation, live plant material should be transported as rapidly as possible, which usually means by air, using the pressurised compartment of the aircraft. Except for seeds, surface mail should not be used for long-distance transport of plant specimens. 1.5

Guidelines for the Transportation of Animals

Controlled materials that require a VS 16-6 interstate transport permit include live microorganisms (e.g. bacteria, viruses, fungi, protozoa, and TSE agents) that are pathogenic to livestock or poultry and vectors of livestock or poultry pathogens. Transportation of non-pathogenic microorganisms do not require a VS permit.
